

- **1. AGREEMENT TO FOLLOW DIRECTIONS.** I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by the PVG&MC, or its representatives or agents.
- 2. ASSUMPTIONS OF THE RISKS AND RELEASE. I recognize that there are certain inherent risks associated with the above described activities and I assume full responsibility for personal injury to myself, and further release and discharge the PVG&MC for injury, loss or damage arising out of my use of or presence upon the facilities of the PVG&MC, whether caused by the fault of myself, the PVG&MC or other third parties.
- **3. INDEMNIFICATION.** I agree to indemnify and defend the PVG&MC against all claim, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my minor children's use of or presence upon the facilities of the PVG&MC.


